- (2) 歡迎使用古蹟辦網頁的電子表格遞交申請。參加者亦可將已填妥的申請表格透過電郵（enews@amo.gov.hk）、傳真（2377 9792）及郵寄交回古蹟辦。
- (3) 文物之友的活動訊息會透過古蹟辦網頁的「文物之友專區」及電郵發放給會員。
- (4) 活動除特別註明外，將以粵語進行。
- (5) 活動報名如超額，將以抽籤選出參加者。活動截止報名日期後若尚餘名額，則以先到先得原則分配。
- (6) 古蹟辦保留活動安排的最終決定權。

2. Welcome to submit application through the e-form on AMO's website. Alternatively, you can send your completed application form to AMO by email (enews@amo.gov.hk), fax (2377 9792) or post.
3. FOH activities will be promoted through the FOH webpage and email.
4. Unless otherwise specified, all FOH activities will be conducted in Cantonese.
5. If the quotas of the FOH activities exceed, participants will be selected by lot drawing. If there are places left after application deadlines, they will be allocated on a first come, first served basis.
6. AMO reserves the rights of final decision on the arrangements of activities for the FOH Scheme.
